Notification no.69/2015, dated 17 December 2015 Sub: Activation of online application form for DDU-GKY Project Proposal Submission

- In continuation to Notification no. 28/2015 dated 15.6.2015 of Ministry of Rural Development, it is hereby stated that the Online Project Application Form under DDU-GKY (including Roshni initiative) is available at website: www.ddugky.gov.in.
 All registered organizations with valid Permanent Registration Numbers (PRN) shall be required to file their project applications online. The online application is mandatory for obtaining new projects in Odisha State.
- 2. An organization with a valid Permanent Registration Number (PRN) may apply for a project with its user credentials (Username and Password) that has been made available to the organization along with the PRN. User manual for submission of Online Project Application is available under "Resources" tab at www.ddugky.gov,in
- 3. Application may now be called for in the notified Online Application Format.
- With effect from the date of notification, a non-refundable application processing fee shall be charged as given below.

5. It is further stated that the Ministry of Rural Development and State shall separately notify an e-payment procedure for project application fees. Till such time, project application fees shall be paid by all project applicants using RTGS/NEFT into the bank account as given below:

6. Application fee is non-refundable in any or all circumstances. It is also stated that submission of project application fee does not guarantee sanction of a project. The sanction of project is subject to fulfillment of DDU-GKY Guidelines, appraisal processes, and notifications issued by the Ministry of Rural Development and Odisha State from time to time.

- 7. For any technical support or complaint regarding the online project application, any agency implementing DDU-GKY or any registered organization with a valid PRN, may register a query/complaints/Grievance at the Help Desk available at http://ruralskills.in:4040/trac/MrigsSSP. Complaints/Queries/Grievances of the applicant organizations shall not be entertained in person in the Rural Skills Division of State.
- 8. In Case of any claims relating to application processing fee charged for an application for sanction of a project in state, an appeal shall primarily lie with Appellate Authority notified by the concerned State Government, whose decision shall be final. Where an Appellate Authority has not been notified, Secretary (Panchayati Raj) in the State Government shall be the deemed Appellate Authority.
- 9. This notification is issued with the approval of the Competent Authority, Odisha and comes into force with effect from the date of notification.
