The quotations will be opened on dt.13.01.2016 at 10:30A.M in the office of PD DRDA, Sundargarh in presence of the quotationers or their representatives. TERMS AND CONDITIONS OF TENDER FOR SUPPLY OF SOUND SYSTEM FOR STAGE

- 1 . Experience certificate of successful completion on similar works during last three year
2. The Value of the work executed should not be less than Rs.0.50 lakhs in single work order in each of the last 3 years
3. The bidders should furnish VAT clearance certificate, Income Tax clearance certificate and Service Tax clearance certificate as on 31.03.2015 (Latest Deposit Challans should be attached).
4. The rate offered by the firm must be inclusive of all taxes and duties.
5. The duration of the exhibition will be of 5 days. The venue shall be made available to the contractor before 10 days of commencement of the exhibition. All the desired works should be completed on 26.01.2016 by 10.30 am and it should be handed over to the in-charge of exhibition latest by 11:30 am on same day
6. The bidder shall quote their price for all the items under this package (ie, Sl. 1 to 13).
7. The bidder has to quote the rate as per the given format.
8. On completion of the exhibition, the contractor shall have to take away all the materials

8. On completion of the exhibition, the contractor shall have to take away all the materials within seven days & vacate the place with the same condition while occupying the ground.

9. The final payment will be made on the basis of the actual work done and Work Assessment Report in the specified format by the Mela-in-charge. The contractor shall not use any additional materials other than the work specified in the work order without the prior permission of the Mela-in-charge. In case of any additional requirement, the contractor has to take the prior written permission from the Mela-in-charge.

10. The bidder along with manpower and the committee formed by the mela-in-charge should do a proper assessment and the actual work done during the mela period.

11. Bidder will be responsible for upkeep and maintenance of the entire work done by him till the closing of the exhibition. The authority will not responsible for any breakage, damage, fire, theft etc. of his materials and insurance if any.

12. No part of the contract will be sub-let to others.

13. The quality of sound system must be of very good quality during the programme .

14. For convenience and effective delivery, the tender is to be treated as a package of services. Whose total quoted price for the Complete package will be lowest ,he will be consider as L-1

15. The bidders are required to deposit an earnest money deposit of Rs.10,000/- (Rupees ten thousand)only in shape of demand draft/pay order in favour of "Project Director, DRDA, Sundargrh" payable at Sundargrh. The E.M.D. amount of the successful bidder will be kept with PD,DRDA till the completion of the exhibitions and will be refunded after completion of the exhibition. In case of any unsatisfactory work, delay in execution of work etc. the E.M.D amount will be forfeited as per the decision of the authority. Tender papers without E.M.D shall not be accepted.
