A) <u>About the Event – SISIR SARAS</u>

Ministry of Rural Development, Government of India has sanctioned a **national level marketing event named as "SISIR SARAS" to be held from 1st January to 13th January 2016** at the Exhibition Ground, Unit- III, Bhubaneswar.
