### Terms of Reference for Food Stalls of JAGANNATH SARAS - 2015

#### A. Background:

Odisha Rural Development and Marketing Society (ORMAS) was constituted in the year 1991 under Societies Registration Act, 1860 as an autonomous body under Panchayati Raj Department, Government of Odisha.ORMAS works in the field of Rural development & rural livelihood. It provides training, technology & marketing support to the rural poor. In the long run enhancing the quality of life of the rural producers. The district units of ORMAS are known as District Supply & Marketing Society (DSMS). These units are functioning with the basic objective to help rural poor to make a better living by enabling them to improve their production, processing and marketing. DSMS PURI also acts as a facilitating agency for implementation & monitoring of rural livelihoods programmes for the rural producers in the district.

Nabakalebar is all about transformation of Puri temple, the daities of Lord Jagannath, Balabhadra, Goddess Subhadra and Sudarshan into the new body. The new wooden idols of Lord Jagannath, Balabhadra, Goddess Subhadra and Sudarshan are welcomed to the temple with great celebration and it is a great event in the cultural calendar of Odisha and among the Hindus. The new idols are carved and old ones are cremated with rituals mentioned in the century old scripture. Depend on the almanac positions of Hindu calendar the transformation or the Nabakalebar takes place once in every 12 to 19 years. Usually it is held in that year when the month of Asadha is followed by another Asadha. The devotees are getting the opportunity to see changing form of lords this year 2015 after 19 years; the previous Nabakalebar was taken place in the year 1996.

2015 is a great year for Lord Jagannath devotees as they are going to witness the rare Nabakalebar at the time of Car Festival. This special celebration will be held on 18th July 2015 in the holy city of Puri, Odisha, at the time Car Festival, from 18<sup>th</sup> to 26<sup>th</sup> July 2015. It is hoped that, 30 lakhs of devotees & visitors from all over world will visit Puri, during this holy festival. In Last 15 year ORMAS has been involved in organising melas for rural producers in PURI during the Car Festival.

An Exhibition in the most general sense is an organized presentation and display of selection of items. Exhibition/Mela has been part and parcel of entertainment and relaxation activity of our culture; DSMS PURI has used this medium as a channel to promote rural products made by the Institutions of poor. The experience shows that this has been a very good Platform for business of Rural Products

DSMS PURI organises exhibition in support of District Administration and collaboration with Odisha Livelihoods Mission (OLM), and other line departments and organisations involved in rural entrepreneurship, income generating activities to provide a better quality of life to the rural producers [DC (Handicraft), KVIC/KVIB, Department of H & CI, TDCC, ORTSS, COIR CORPORATION MVSN and NABARD] with an objective to provide a platform to the rural producers to showcase their products for direct sale, interact and get taste, choice & preferences of urban consumers. It also helps the rural entrepreneurs identify livelihood opportunities and establish links with the markets in urban and semi-urban areas.

The overall objective of the mela is to popularize the ethnic and other rural products of Odisha and create opportunities for the artisans/producers to build up long term marketing tie-up with prospective buyers.

#### B. TERMS & CONDITIONS

- 4 No. of Stalls(food) will be available by DSMS PURI for sales of food items during the Jagannath SARAS. It is the responsibility of the firm to provide hygienic food as per the specification.
- The deposit amount has to be made by the firms on dated 17.7.2015 at 10.30 A.M. at mela ground.
- 3. One firm is authorized to bid for one stall only.
- The bill should accompany with the challan of receipt. The offer price should include all taxes & duties.
- 5. The bidders are required to deposit an earnest money of Rs. 10,000/- (Rupees Ten thousand only) in shape of demand draft/pay order in favor of DSMS PURI payable at Puri. The E.M.D. amount of the successful bidder will be kept with DSMS PURI till the completion of the exhibitions i.e. JAGANNATH SARAS). In case of any unsatisfactory food quality provided during the time of Mela the E.M.D amount will be forfeited as per the decision of the authority. Tender papers without E.M.D shall not be accepted.
- The rate offered by the firm should be valid till completion of the JAGANNATH SARAS

- 7. The tenderers have to offer the price as per the prescribed format as per Annexure-A or else the tender paper will not be considered.
- The rate offered by the firm shall be including of all taxes and duties including Service Tax.
- 9. Food Stalls will be allowed to sale Veg Products only.

- v. Valid Sales Tax & VAT Clearance certificate 2015-16
- vi. Self attested Photo copy of certificate attached.
