Terms of Reference for Printing works of National level Pallishree Mela - 2019

A. Background:

Odisha Rural Development and Marketing Society (ORMAS) was constituted in the year 1991 under Societies Registration Act, 1860 as an autonomous body under Panchayati Raj Department, Government of Odisha. ORMAS works in the field of Rural development & rural livelihood. It provides training, technology & marketing support to the rural poor. In the long run enhancing the quality of life of the rural producers. The district units of ORMAS are known as ODISHA RURAL DEVELOPMENT & MARKETING SOCIETY (ORMAS). These units are functioning with the basic objective to help rural poor to make a better living by enabling them to improve their production, processing and marketing. ORMAS, PURI also acts as a facilitating agency for implementation & monitoring of rural livelihoods programmes for the rural producers in the district.
