B. Introduction

Odisha Rural Development and Marketing Society (ORMAS), an autonomous body under Panchayati Raj & Drinking Water Department Government of Odisha,formed under Societies Registration Act, 1860 and 14th January 1991.

Odisha is a leading performing state across the country in implementation of DDU-GKY. It is foremost in many interventions and invented best practices in due course of implementation of DDU-GKY in partnership with the PIAs. It has also best performed in mobilization & counselling. Even after that, there is a need to strengthen the mobilization & counselling process by using effective electronic media tools.

Use of electronic media tools are effective mechanism to mobilize youth under DDU-GKY. It was observed in due course of mobilization & counselling processes that larger no. of community mobilizers as well as potential youth have less clarity about sector/ trades, job roles, career progression and location of placement. This has been further affecting in decision making by potential youth for opting DDU-GKY as option for career for skill training. Presently, leaflet and brochures are provided to youth & community mobilizers at the time of awareness & counselling but there is a need to develop a short video documentary for demystification of sectors / trades.

C. Objective: The objective of producing such video are:

- Enhancing awareness and knowledge levels of potential youth about sector / trades offered under DDU-GKY
- Generating demand for DDU-GKY training in different trades / sector as per interest of youth
- Strengthening the enabling environment that reinforce positive attitudes towards DDU-GKY

D. Scope of Work: -

The duration of the video may not exceed 10 minutes as it will be used in different awareness generation and training programme in districts, blocks and gram panchayats.

The detail script will be provided by the IEC Team (DDU-GKY) of ORMAS.

E. Bid Price

- 1. The Quotation shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and re-writing.
- 2. All duties, taxes and other levies payable by the Agency under the quotation shall be excluded in the total price.
- 3. The rates quoted by the Agency shall be fixed for the duration of the contract and shall not be subjected to adjustment on any account.
- 4. The Prices should be quoted in Indian Rupees only.
- **F. Bid Validity:** Bid validity period is 30 days from the bid due date i.e. last date of submission of tender.

G. Submission of Tender:

Bidder must submit their tenders through <u>Registered Post / Speed Post / Courier / Tender Box</u> to the specified address on or before 12.02.2020 at 3.30 PM. The ORMAS will not be responsible for postal delay / any consequence in receiving of the proposal. Any Proposal received after the deadline will be out rightly rejected. The bidder shall submit the prerequisite documents along with Price quotation in one envelope.

H. Evaluation of Tender

- A. The ORMAS will evaluate and compare the quotations determined to be substantially responsive i.e. which
 - 1. are properly signed; and
 - 2. Confirm to the terms and conditions, and specifications.
 - 3. Filled in Indian Currency
 - 4. Quoted in Unit

I. Eligibility Criteria:-

The bidder shall furnish the following documents to establish the bidder's eligibility:-

- 1. The agency must be a registered firm / Sole Proprietorship and must have audio visual production houses experience in Odisha.
- 2. The firm / agency should have its own office / organization within Bhubaneswar.
- 3. The bidder must submit the GSTIN / PAN Certificate
- 4. The agency must have completed atleast one similar assignment in the FY 2016-17, 2017-18 & 2018-2019).

J. Other Terms & Conditions

- i. The price and work order is valid for one year.
- ii. Joint CEO, ORMAS will act as Nodal Officer for monitoring & supervision of the entire activity and performance.
- iii. The contract will be awarded to the Agency/ sole proprietor whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
- iv. The authority is not bound to accept the lowest quotation and reserve the right to reject any or all quotations and tenders without assigning any reasons thereof.
- v. Notwithstanding the above, the authority reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- vi.100% Payment shall be made immediately as far as possible after successful delivery as per specification.
- vii.Rate quoted shall be indicated both in words as well as in figures. Where there is difference between the amounts quoted in words and figures, amount quoted in words shall prevail.
- viii. The bidder shall quote the price within the latest approved I&PR rate. Above the I&PR rate shall not be considered.
- ix. If any price quoted by the bidder found equal or tie, the maximum nos. of government assignment shall be considered for awarding the assignment..
- x. The Agency has to quote the rate as per the given format.
- xi. No part of the work will be sub-let.
- xii. The Agency or the representative of the Agency shall attend the tender opening meeting as per the schedule fixed.
- xiii. Non-submission of any document required indicated in the tender document will render the Bid to be rejected.

L. Anti-corruption Measure:

- a. Any effort by Agency(s) to influence the ORMAS in the evaluation and ranking of financial proposals, and recommendation for award of contract, will result in the rejection of the proposal.

A recommendation for work order shall be rejected if it is determined that the recommended Agency has directly, or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the contract in question. In such cases, the ORMAS shall blacklist the Agency either indefinitely or for a stated

N. Penalty:

Any unjustified and unacceptable delay in delivery shall render the Agency liable for liquidated damages and thereafter the ORMAS shall fix suitable penalty in full or part from invoice.

O. Arbitration:

In the event of any question, dispute or difference arising under these conditions contained in the Work Order in connection with this contract, the same shall be referred to the CEO, ORMAS, Bhubaneswar whose decision will be treated as final and binding on both the parties.
