- 8. The delivery of the sold vehicle will be given only after the successful bidder submits the documentary evidence in support of residential status (Voter ID/Aadhar card/Ration card in case of individual and Registration certificate in case of firm etc.)
- **9.** The sold vehicle shall have to be removed by the successful bidder within 7 days at his own expenses from the premises after the date of full payment of the tender amount.
- 10. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of 1% of the tendered/negotiated money shall be charged for each day or part of the day till removal of the vehicle from the site.
- 11. Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle. The amount deposited by him/her shall be adjusted towards the ground rent and the vehicle shall become absolute property of Government free from all encumbrances.
- **12.** The successful bidder will also be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost expeditiously. This Office will not be responsible for any lapse on his part in this regard.
- 13. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reason arise, the same will be opened the next immediate working day at the same time.
- 14. If the highest quoting firm fails to honour the bid; the contract will be cancelled. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid.
