d) GST registration certificate.

e) Valid Electric License from Electrical Board Licence of Odisha.

f) Experience in similar work.

g) Price Bid in the prescribed format duly signed and sealed in each page.

5. Award of Contract

a) The Purchaser will award the contract to the bidder whose tender has been determined to be substantially responsive and who has offered the lowest total price.

b) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

6. Payment shall be made after successful execution of electrical work by account transfer after

submissions of proper bills and voucher.

7. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

8. Any legal dispute arising out of this is subject to concerned district jurisdiction only.

Notwithstanding the above, ORMAS, Bhubaneswar reserves the right to accept or reject any quotation and to cancel the bidding process and reject all bids at any time prior to the issue of contract letter.

10. The original certificate relating to Vendor Registration Certificate, GST, IT registration, PAN etc. may be produced for verification when asked for.

11. Tender papers received beyond the stipulated date and time, and other required document shall be liable for rejection. The authority will not be held responsible for postal delay in the delivery of the documents or nonreceipt of the same.
